- 2. All references to 'Parents and Carers' include Grandparents, Relatives, Friends and Volunteers.

Underlying Assumptions, Philosophy and Rationale:

We at All Saints Catholic Primary School believe/understand that:

- safety, a basic human right, is a pre-requisite for our school to be able to carry out our mission to educate
- children have the right to be emotionally and physically safe at all times
- the dignity of the human person is fundamental to Catholic teaching
- we operate in a wider community context where legal requirements exist
- we have a duty of care to all children enrolled at All Saints Catholic Primary School.

Purpose/Aims:

Through the application of this policy, we at All Saints Catholic Primary School aim to:

- ensure the safety and wellbeing of the child is considered paramount in every situation
- ensure that the underlying values of our guiding principles reflect the way we build and restore relationships.

Guidelines:

In support of this policy:

The Principal will:

- ensure that all children have an understanding of this policy including the flow chart that outlines the steps they need to take to achieve a positive resolution to their problem
- encourage children to participate in the review of this policy
- encourage children to learn strategies in problem solving
- encourage staff members to listen carefully to children and to counsel them appropriately in self managing their problems or offering more direct assistance as needed.

All Staff members will:

- ensure they are fully aware of this policy and teach the children the steps they need to take to achieve a
 positive resolution to their problem
- provide opportunities for children to role play and practise problem solving situations
- help children to understand the difference between those problems that need help from an adult and those that can be solved without adult intervention

- help children to understand the importance of reporting something that is serious, may cause harm or is illegal
- work closely with parents or carers when necessary to support children in achieving a positive resolution to their problem.

Children and Young People will:

- follow the steps required, as set out in the Positive Resolution Guide for Children and Young People flowchart, to achieve a positive resolution to their problem
- seek support from their parents/carers, class teacher or suitable adult to support them to achieve a solution to their problem.

Parents/Carers will:

- ensure they are fully aware of this policy and support their child(ren) when seeking a positive resolution to their problems
- work closely with the school when necessary to support their child(ren)
- help children to understand the importance of reporting something that is serious, may cause harm or is illegal.

Implementation

- All staff members will have access to this policy
- All parents/carers or volunteers who have direct supervision of children will be made aware of this policy
- All parents/carers and community members will be informed of this policy via the newsletter and the school's website
- The flowchart will be displayed in each classroom so that children are aware of the steps they need to take to achieve a positive resolution to their problems
- The names of all relevant Government Agencies will be checked and updated on the review date of this policy.



5 FINGER RULE FOR SOLVING A PROBLEM



- 1. Ignore the inappropriate behaviour.
- 2. Move away from the problem and play with somebody else.
- 3. If they follow you, explain how you are feeling and why.
- 4. If it continues, say "Stop, I don't like it".
- 5. If you have tried all these steps and the problem is not solved, then it is time to ask a teacher for help.
